State of Georgia Clean Water Base and Supplemental State Revolving Fund Program State Fiscal Year 2023 Annual Report

Introduction

The Clean Water State Revolving Fund (CWSRF) provides assistance to wastewater and nonpoint source projects that improve water quality in Georgia as identified in the amended Clean Water Act of 1972. A range of water quality and wastewater treatment projects are covered by the program, including:

- Stormwater and flood control projects,
- Projects for the construction or expansion of wastewater treatment facilities and installation of sewer lines and sewer rehabilitation,
- Projects that support the state's nonpoint source management plan, and
- Projects that reduce energy costs, such as solar, wind, and biogas projects.

As required by the Code of Federal Regulations, Title 40, Part 35, Subpart K, Section 35.3165; Section 606, Paragraph (d) of the Clean Water Act; and Chapter 6 of the CWSRF Management Manual of December 1988, the Georgia Environmental Finance Authority (GEFA) submits this annual report for the state fiscal year ending June 30, 2023 (FY2023). This report provides detailed information concerning the management and fiscal integrity of the program, changes to the program, and updates to the program's goals and objectives relating to the 2022 CWSRF Base and Supplemental Intended Use Plans(IUP).

GEFA was created by the Georgia General Assembly in 1986 as the successor agency to the Georgia Development Authority Environmental Facilities Program. GEFA assists local governments in financing the construction, extension, rehabilitation, replacement, and securitization of public works facilities. The GEFA board of directors consists of three exofficio members and eight members appointed by the governor. The Georgia Environmental Protection Division (EPD) provides certain professional services for the CWSRF. These services include:

- Project reviews and approvals;
- Planning and project development;
- Information tracking;
- Information gathering and assistance with the National Needs Survey;
- Issuing Notices of No Significant Impacts (NONSI) and Categorical Exclusions (CE);
- Assistance with the National Information Management System (NIMS); and
- The Clean Water Benefits Reporting (CBR) database.

Executive Summary

In August 2022, GEFA submitted an IUP and application for the 2022 Base CWSRF grant. The 2022 base grant was awarded on September 29, 2022, for \$19,563,000. In June 2023, the 2023 base grant application and IUP were submitted to the U.S. Environmental Protection Agency (EPA) for \$12,683,000 and has not been awarded. Funds awarded by EPA to Georgia's CWSRF as of June 30, 2023, total \$918,094,061, including \$24,672,170 net transfers from the Drinking Water State Revolving Fund (DWSRF). There were no net transfers from DWSRF for state FY2023. Georgia's required state match totals \$161,378,462.

In December 2022, GEFA submitted an IUP and application for the 2022 Supplemental CWSRF grant. The 2022 supplemental grant was awarded on April 5, 2023, for \$30,092,000. In June 2023, the 2023 supplemental grant application and IUP were submitted to the U.S. Environmental Protection Agency (EPA) for \$35,242,000 and has not been awarded.

Funds awarded by EPA to Georgia's CWSRF supplemental as of June 30, 2023, total \$30,092,000. There were no net transfers from supplemental DWSRF for state FY2023. Georgia's required state match totals \$3,009,200.

Attachment 1 shows the total sources of funds by quarter during state FY2023 including federal grant funds, state match contributions, repayments from direct federal loans, and interest earnings generated from these accounts. Attachment 1 also shows the closing fees collected by quarter identified as program income and non-program income. Georgia reports the collection of program income and non-program income separately in accordance with the EPA Fee Guidance released in October 2005. Attachment 1 also shows the uses of funds by quarter. Attachment 2 shows the balances within these accounts as of June 30, 2023.

Under the CWSRF, 22 new loans were executed in state FY2023 for a total of \$309,395,900. These CWSRF loans include \$2,000,000.00 in principal forgiveness and \$13,985,881.00 that met the qualifications for the Green Project Reserve. These executions and increases can be found in Attachment 3. Attachment 4 shows information for these 22 projects in the NIMS format. Lastly, GEFA and EPD collectively entered all necessary information into the Clean Water Benefits Reporting database for all projects funded through state FY2023.

All new loan commitments were made to qualified local governments or water and sewer authorities according to the requirements of the Georgia Department of Community Affairs (DCA), which includes a verified service delivery strategy. Additionally, all loan recipients have the technical, managerial, and financial capability to operate a sewer system. Each project was reviewed in accordance with the EPA approved State Environmental Review Process (SERP) and was issued a Notice of No Significant Impact (NONSI) or a Categorical Exclusion (CE). Below is a short description for each of the projects funded in state FY2023.

Additional Subsidization Projects

Toccoa (CW2020013)

On October 24, 2022, Toccoa signed a \$9,137,000 assistance agreement, including \$900,000 in principal forgiveness. This project includes upgrading the Eastonolle Creek Water Pollution Control Plant. As of the end of state FY2023, \$3,988 have been drawn.

Wrightsville (CW2019009)

On August 18, 2022, Wrightsville signed a \$7,073,000 assistance agreement, including \$1,100,000 in principal forgiveness. This project includes upgrading the water pollution control plant. As of the end of state FY2023, no funds have been drawn.

Green Projects

Banks County Board of Commissioners (CW202029A)

On February 17, 2023, Banks County signed a \$17,500,000 assistance agreement. The project includes constructing a new water reclamation facility and improving the sewer system. As of the end of state FY2023, no funds have been drawn.

Columbus Water Works (DW2020019A)

On May 5, 2023, Columbus Water Works signed a \$8,869,800 assistance agreement. The project includes rehabilitating the wastewater treatment facilities and sewer collection system. As of the end of state FY2023, no funds were drawn.

Columbus Water Works (CW2020020A)

On May 5, 2023, Columbus Water Works signed a \$11,230,200 assistance agreement. The project includes rehabilitating the wastewater treatment facilities and sewer collection system. As of the end of state FY2023, no funds have been drawn.

East Point (CW2021003)

On August 26, 2022, East Point signed a \$2,000,000 assistance agreement. The project includes rehabilitating the sewer system. As of the end of state FY2023, no funds have been drawn.

LaFayette (CW2020027)

On March 8, 2023, LaFayette signed a \$1,350,000 assistance agreement. This project includes replacing a pump station and installing sewer lines. As of the end of state FY2023, no funds have been drawn.

Senoia (CW2022010)

On July 7, 2022, Senoia signed a \$3,000,000 assistance agreement. This project includes upgrading and improving the sewer system. As of the end of state FY2023, \$2,178,609.73 have been drawn.

Thomasville (CW2022025)

On March 21, 2023, Thomasville signed a \$7,890,000 assistance agreement. This project includes making improvements to the wastewater treatment plant and install outfall sewer main. As of the end of state FY2023, no funds have been drawn.

Walker County Water and Sewerage Authority (CW2019019A)

On March 14, 2023, Walker County Water and Sewerage Authority signed a \$10,000,000 assistance agreement. This project includes constructing new pump stations, installing sewer mains, and making improvements to the Walker County Wastewater Treatment Plant. As of the end of state FY2023, no funds have been drawn.

Base CWSRF Projects

Bartow County (CW2020004)

On February 22, 2023, Bartow County signed a \$25,000,000 assistance agreement. The project includes constructing a new West Bartow Water Pollution Control Plant. As of the end of state FY2023, no funds have been drawn.

Clayton County Water Authority (CW2022023)

On December 9, 2022, Clayton County Water Authority signed a \$50,000,000 assistance agreement. The project includes upgrading the biosolids management at the W.B. Casey Water Reclamation Facility. As of the end of state FY2023, no funds have been drawn.

Columbus Water Works (CW2022032)

On June 16, 2023, Columbus Water Works signed a \$7,526,000 assistance agreement. This project includes upgrading the South Commons combined sewer overflow (CSO) and constructing a new pre-treatment facility upstream of the Uptown CSO facility. As of the end of state FY2023, no funds have been drawn.

Covington (CW2021035)

On July 19, 2022, Covington signed a \$26,239,000 assistance agreement. This project includes upgrading the Covington Water Reclamation Facility and sewer collection system. As of the end of state FY2023, no funds have been drawn.

Cumming (CW2021013)

On January 24, 2023, Cumming signed a \$17,000,000 assistance agreement. This project includes upgrading the Behelview Road Advanced Water Reclamation Facility. As of the end of state FY2023, no funds have been drawn.

Gwinnett County (CW2022031)

On May 1, 2023, Gwinnett County signed a \$50,000,000 assistance agreement. This project includes constructing a biosolids dryer at the F. Wayne Hill Water Resources Center. As of the end of state FY2023, no funds have been drawn.

Jefferson (CW2022002)

On March 21, 2023, Jefferson signed a \$23,730,000 assistance agreement. This project includes constructing a new water pollution control plant. As of the end of state FY2023, no funds have been drawn.

Lumpkin County Water and Sewerage Authority (CW2022028)

On August 2, 2022, Lumpkin County Water and Sewerage Authority signed a \$825,000 assistance agreement. This project includes planning, designing, and permitting services to construct a new wastewater treatment plant. As of the end of state FY2023, \$640,248.98 have been drawn.

McIntyre (CW2021012)

On November 22, 2022, McIntyre signed a \$3,128,000 assistance agreement. This project includes constructing a new sewer collection system. As of the end of state FY2023, \$1,577,647.75 have been drawn.

Oconee County Board of Commissioners (CW2022030)

On May 15, 2023, Oconee County Board of Commissioners signed a \$25,000,000 increase to the existing \$9,137,100 assistance agreement entered on January 19, 2021. This project includes upgrading the Calls Creek Water Reclamation Facility. As of the end of state FY2023, no funds have been drawn.

Paulding County (CW2021022)

On August 18, 2022, Paulding County signed a \$1,190,000 assistance agreement. This project includes extending sanitary sewer lines. As of the end of state FY2023, \$171,088.67 have been drawn.

Villa Rica (CW2023008)

On June 29, 2023, Villa Rica signed a \$1,707,900 assistance agreement. This project includes upgrading the pump station. As of the end of state FY2023, no funds have been drawn.

Meeting Intended Use Plan (IUP) Goals and Objectives

The 2022 CWSRF Supplemental and Base IUP listed five goals for the program.

1. Long-term Program Goal: Coordinate activities with other state and federal agencies to enhance borrowers' understanding of the range of funding options. Seek opportunities to leverage funds so that borrowers can benefit from the maximum level of public assistance available.

Status: Georgia has an organization called the Georgia Funders' Forum that convenes quarterly to discuss updates to funding programs. Some of the funding agencies/programs represented are United States Department of Agriculture (USDA), DCA, Georgia Emergency Management Agency (GEMA), Community Development Block Grant (CDBG), Appalachian Regional Commission (ARC), and GEFA. The participants learn from each other and benefit from guests on topics selected by the participants themselves. The participants discover how to create more efficient and effective ways to distribute limited dollars for water projects in Georgia.

2. Long-term Program Goal: Maintain and improve database management systems that integrate Clean Water project data with program management data.

Status: GEFA selected a comprehensive database management system that will allow borrowers to manage and

track loan funds, repayments, set-aside spending, capital, and financial contributions. The goal is to automate tasks and allow the borrowers to enter and view their current information. This comprehensive database will reduce errors and increase efficiency in program management. The kickoff meeting was October 1, 2021, and the system went live internally April 1, 2023.

3. Short-term Program Goal: Expand and broaden GEFA's community outreach activities to ensure that borrowers and utilities are aware of and understand CWSRF assistance options and the loan application process.

Status: GEFA's water resources division worked closely with the public affairs division to increase awareness around the SRF program. Both divisions participated in conference presentations, workshops, training sessions, and meetings with potential borrowers.

The WaterFirst program recognizing local governments for achieving excellence in water resources management. Becoming a WaterFirst Community demonstrates a local government's commitment to responsible water stewardship for environmental and economic benefits. Communities that earn the WaterFirst designation are eligible for financial and other benefits from the state of Georgia. GEFA held a WaterFirst Workshop in Dawson Georgia. This workshop provided an overview of the WaterFirst program and discussed water, wastewater, and stormwater funding options.

4. Short-term Program Goal: Prioritize disadvantaged communities that have notice of violations or consent orders.

Status: The 2022 CWSRF base call for projects gave 30 points to communities for projects needed to fully address deficiencies documented in Emergency or Administrative Order from EPA or EPD. The 2022 CWSRF supplemental call for projects increased those points to 50 to ensure those projects were given top priority.

5. Short-term Program Goal: Continue to use the GEFA conservation initiative with its interest rate reductions to promote energy, land, and water projects.

Status: GEFA continues to offer a 1% interest rate reduction for those projects that are 100% conservation. If the project is not 100% conservation, GEFA offers a blended interest rate based on percentages of conservation and non-conservation components.

Program Administration (4 Percent)

GEFA used repayment dollars and program income for administrative purposes. Attachment 5 shows expenditures associated with program administration broken down by object category.

CWSRF Non-Program Income

In state FY2023, GEFA spent \$1,182.97 in CWSRF non-program income to support the state's water quality monitoring, testing, and standards development. Attachment 5 shows how non-program income was allocated.

Disadvantaged Business Enterprise (DBE) Participation

Within GEFA's agreement, recipients are required to encourage participation of small minority and women owned businesses in all project subcontracts. The state's CWSRF percentage goals through September 30, 2022, are four percent for Minority Business Enterprises (MBE) and four percent for Women Business Enterprises (WBE). A summary of DBE utilization is in Attachment 6. The data provided in Attachment 6 is for the reporting period of October 1, 2021, through September 30, 2022, representing the most recent full fiscal year of data.

GEFA makes every effort to comply with the EPA's Six Good Faith Efforts. Telephone calls and emails are regularly made

to DBE subcontractors to encourage their participation in both the CWSRF and DWSRF projects. DBEs are alerted to GEFA-approved projects as soon as they appear in the database, allowing subcontractors to inquire and prepare for these projects prior to the bid date. Subcontractors are additionally urged to pursue EPA/Georgia Department of Transportation (GDOT)/Small Business Administration (SBA) certification. GEFA staff are available to answer questions and assist subcontractors in the application process. GEFA also maintains an in-house bidder's list of certified DBE prime contractors and subcontractors. The data for the bidder's list is collected and forwarded to loan recipients with compliance approval. The bidder's list also serves as a database of MBEs and WBEs and non-MBE/WBE prime contractors and subcontractors.

In considering whether firms could subcontract with DBEs, GEFA encourages prime contractors to follow the Six Good Faith Efforts to solicit the services of MBEs and WBEs. Project approval is withheld if DBE documentation is insufficient. Prime contractors are also provided with an example of an EPA-approved newspaper advertisement and an example of a solicitation letter to help eliminate generic newspaper advertisements and poorly written letters. GDOT, city of Atlanta, SBA, and Metropolitan Atlanta Rapid Transit Authority (MARTA) are resources for prime contractors for identifying DBE-certified subcontractors. In addition, an EPA bidder's list is available upon request from GEFA. Guidance is provided in all related construction contracts to encourage prime contractors to divide work when feasible.

CWSRF Loan Disbursements

The CWSRF disbursed funds to 60 active projects during state FY2023. Attachment 7 shows the projects that received funds by quarter in state FY2023. The CWSRF disbursed a total of \$125,335,296.65 in state FY2023. Attachment 8 compares the projected disbursement schedules indicated within the 2021 and 2022 IUPs for state FY2023 against the actual disbursements made in state FY2023. The CWSRF disbursed 318 percent of projected disbursements in state FY2023.

CWSRF State Match

Under the provisions of the Federal Water Pollution Control Act (FWPCA) Section 602(b)(2), the state is required to deposit an amount equal to 20 percent of the total base capitalization grant and 10 percent of the total supplemental into the CWSRF. GEFA will draw down federal dollars exclusively while applying \$3,912,600 of overmatch credit for base. Bond funds were used as match for supplemental in the amount of \$3,009,200 and were deposited before any supplemental grant funds were drawn. At the start of FY2023, there was \$11,208,851 remaining of overmatch credit. Therefore, Attachment 1 shows a state match of zero due to the overmatch being reported in the year it was deposited for base. Attachment 1 shows the amount of state match funds provided during state FY2023 by quarter.

CWSRF Loan Repayment

Ten CWSRF projects closed during state FY2023 (Attachment 9). The total dollar value awarded to these projects equaled \$121,998,000 of which \$118,613,845.65, or 97.23 percent, was disbursed. The total amount of repayments credited to the CWSRF during state FY2023 for CWSRF base from all sources was \$80,979,967.69 and can be found within Attachment 1 (total of federal and state-match repayments). These sources of repayment include principal and interest payments and any late fees or loan continuation fees paid. To maintain the revolving nature of the CWSRF, all repayments including the principal, interest, and fees are credited to the CWSRF. Attachment 1 also shows that \$2,011,784.60 in closing fees were collected during the state fiscal year.

Water Resources Reform and Development Act (WRRDA) Implementation

WRRDA requires the competitive procurement of architectural and engineering (A&E) services for projects receiving CWSRF assistance. GEFA will be submitting Gwinnett County with a loan amount of \$50,000,000 to meet the equivalency requirement for both the CWSF base and CWSRF supplemental grants.
