I. INTRODUCTION

The Department of Environmental Quality (DEQ) herewith submits the Virginia Clean Water Revolving Loan Fund Annual Report for the period of July 1, 2023, through June 30, 2024. This report describes how DEQ and the Virginia Resources Authority (VRA) have met the objectives identified in the FY 2024 Intended Use Plan and reflects the actual use of available funds. Additionally, this report provides a performance report of DEQ's Sewer Overflow and Stormwater Reuse Municipal Grants Program (OSG) workplan activities in FY 2024.

II. PROGRAM SUMMARY

A cumulative total of \$4,735,405,412.00 in total funds (including \$1,514,252,390 in combined State match and Federal funds, including additional appropriations from the American Recovery and Reinvestment Act of 2009, the Bipartisan Infrastructure Law (BIL), and the Emerging Contaminant (EC) grant funds, have been made available under the loan program since its inception through FY 2024. Please refer to Exhibit 1 for a listing of the Capitalization Grant and State Match amounts. Exhibit 2 illustrates the activity level of the fund.

During FY 2024, DEQ entered binding commitments for program administration and to provide financial assistance to 8 wastewater projects and 85 agricultural BMP loans. Detailed breakdowns of the binding commitments are shown in Figure 1 and Exhibit 2.



As of June 30, 2019, the Department of Environmental Quality's Legacy Ag BMP Loan Program had provided 491 low interest loans to Virginia farmers to assist them with implementation expenses related to 614 agricultural best management practices, as shown below. The program was suspended on July 1, 2016.



Legislative changes were passed in early 2019 and updates to the program guidelines were adopted by the State Water Control Board (SWCB) on June 27, 2019, in preparation to restart the program July 1, 2019. Since restarting in FY 2020, the Ag BMP loan program has received approximately 422 applications for assistance and has closed 137 loans. Figure 3 shows the numbers and types of agricultural BMPs funded by loans closed since the beginning of FY 2020.



A. Development of FY 2024 Project Priority List

EPA approved DEQ's FY 2024 Project Priority List and Intended Use Plan by email dated May 12, 2024. DEQ's Director of Administration, by memorandum dated May 8, 2024, authorized distribution of \$39,784,436 in principal forgiveness funding to eighteen (18) localities for eighteen (18) projects from the FY 2024 solicitation. See Figure 4 for a breakdown of the FY24 funding sources.



The projects receiving additional subsidization met the state's affordability criteria based on high sewer user charges as percentage of median household income, unemployment rate, and population trends and were high water quality projects. Additionally, in FY 2020, DEQ implemented a supplemental use for additional subsidization as an offset to the 0.5% interest rate provided to hardship communities, comprised of 0.2% administration fee and 0.3% interest. This change will provide these communities with the economic equivalent of 0% interest rate to provide affordable funding. See Figure 5 and Exhibit 11 for more information regarding the FY 2024 additional subsidy amounts.

The Federal FY 2024 capitalization grant, BIL supplemental and EC grant agreements also included a requirement that at least 10% of the funds made available by the capitalization grant go to projects meeting the green project reserve (GPR) requirement. DEQ's GPR requirement for FY 2024 was \$6,763,900, which was surpassed by the \$23,236,100 in green projects funded. Exhibit 15 shows the FY 2024 funding priorities and identifies one (1) GPR project receiving \$30,000,000.

B. FY 2025 Project Solicitation

Staff solicited applications from the Commonwealth's localities and wastewater authorities as well as potential stormwater BMP projects, land conservation applicants, brownfield remediation clientele, and living shoreline projects from June 10, 2024, through July 26, 2024. Based on this solicitation, DEQ received twenty (20) applications - eighteen (18) wastewater and two (2) emerging contaminants. As part of the FY 2024 solicitation period, DEQ received four (4) applications for Phase 1 Step 2 of the Southwest Virginia Pilot Program, requesting funding assistance for the highest priority projects identified in the SSES reports generated as part of Phase 1 Step 1 from FY 2021 and 2022. See Figure 6 for details on the amount requested for each funding type.



III. GOALS AND ACCOMPLISHMENTS

In its Intended Use Plan for FY 2024, DEQ identified five (5) long-term and three (3) short-term goals.

Long Term Goals:

 Implement the program in a manner that maximizes its ability to fund Virginia's pressing water quality needs.

Numerous activities and strategies are being implemented to maximize the program's ability to fund Virginia's most pressing water quality needs:

- (a) Modeling of the long-term funding capacity of the VCWRLF has been continued in order to determine the ability of the Fund to provide sustained funding for Virginia's water quality needs.
- (b) Coordination with Virginia's Water Quality Improvement Fund and Stormwater Local Assistance Fund state grant programs has been and will be maintained to maximize use of available resources.

- (c) Close scrutiny is being taken toward ensuring that funded projects have direct water quality benefits.
- (d) Readiness-to-proceed information and cash flow need projections are closely evaluated to ensure that funding resources match needs on a cash flow basis.

• Utilize the 20-year planning model to provide a relevant framework for decision making to maximize the program's capacity for funding.

A 20-year planning model was developed for the program. This model provides a long-term view of the program's funding capacity. Several scenarios were developed through varying input parameters in order to analyze different aspects of the fund capacity. We plan to continue analyzing the planning model in collaboration with the Virginia Resources Authority to enhance and inform decision making for the program.

Improve and expand the program's database system to more effectively and efficiently track and manage VCWRLF projects.

DEQ maintains an agency-wide comprehensive database called Comprehensive Environmental Data System (CEDS). Clean Water Financing and Assistance Program (CWFAP) staff has completed the first and second of multiple phases to enter VCWRLF data into CEDS. The first phase included program specific module creation, testing, project data entry and disbursement processing. The second phase included development of a public portal that allows localities to submit the program application digitally. Future phases will include submission of all disbursement requests digitally; electronic storage of all project documents, which will then be accessible by other DEQ employees in associated programs; integration with Agency financial software, allowing for better tracking of program expenditures; and finally, a connection with our financial partner, the Virginia Resources Authority. It is hoped that by the time these phases are complete, there will be a way to connect the EPA Office of Water State Revolving Funds database with CEDS.

• Maintain a program pace (ratio of cumulative assistance provided to cumulative funds available) of equal to or exceeding the EPA Region 3 average.

This goal was achieved as our cumulative Pace through FY 2024 is approximately 95%.

Implement program changes required by BIL.

On November 15, 2021, the Bipartisan Infrastructure Law (BIL) was signed into law. BIL provides additional appropriations for fiscal years 2022 through 2026 for state Clean Water State Revolving Funds (CWSRF), allows for states to utilize 2% of appropriated funds for technical assistance, and includes additional requirements to be applied to the new appropriations and to the program.

In FY 2024, DEQ CWFAP staff updated the Intended Use Plan to outline how the program plans to incorporate BIL changes and updated the Project Priority List with additional BIL funding

information. Both documents were made available for a 30-day public review and comment period from September 21 to October 20, 2023, no comments were received.

In FY 2022, the program conducted an evaluation of the CWSRF affordability criteria, and it was determined that the criteria meet the requirements of section 603(i)(2) of the Clean Water Act that criteria be based on income, unemployment data, and population trends. Additionally, the priority point system was evaluated for project ranking commensurate with need. The CWSRF ranking categories are project type, environmental concerns, fiscal stress and readiness to proceed. The inclusion of a fiscal stress category in the ranking criteria ensures that applicant need is incorporated into the ranking system. The program recognizes the need to expand its evaluation of these items and plans to conduct an in-depth analysis over the next year, then implement the resulting changes.

Short Term Goals:

Conduct an analysis of technical assistance needs.

In order to provide technical assistance to disadvantaged, small and underserved waterworks, CWSRF is working with the DEQ Wastewater Operations Unit within the Office of Water Compliance to provide different assistance options to cover multiple needs across the Commonwealth.

The first plan is to provide six (6) scholarships to Wastewater Operator Short School – this includes the registration fee, room, board and travel costs. Eligible applicants will be identified by compliance staff and the regional offices and while the criteria for selection are still being finalized, evaluation factors may include demonstration of need, class requested, years working as an operator, and treatment plants that have violations for not having a licensed operator. Applications will be evaluated by DEQ staff and the recipients of the funding will be notified in time to plan for attendance.

The second plan is to provide funding to both Southeastern Rural Community Assistance Project (SERCAP) and Virginia Rural Water, for one (1) full time employee within each program to provide on-site assistance to utilities in need of specific training.

Finally, the third plan is to provide supplemental funding to the Wastewater Operations Unit to hire a summer employee to work with the two wastewater operations specialists while they travel to non-compliant wastewater plants, providing on-site training to all the operators in the plant.

• Enhance engagement with residents and community stakeholders in disadvantaged communities.

In order to support implementation of the EPA Clean Watersheds Needs Survey, DEQ funded completion of a <u>Southwest Regional Wastewater Study</u>. The study recommended creating a regional working group tasked with implementing the recommendations. In late FY2023, DEQ established the Southwest Wastewater Action Group (SWWAG) for this purpose. Members of

the SWWAG include DEQ CWFAP staff, DEQ Southwest Regional Office staff, representatives from the three Southwest Virginia Planning District Commissions, and several consulting engineers working with Southwest localities on wastewater infrastructure projects. Throughout FY2024 the SWWAG met quarterly to implement six main study recommendations: (1) Enhance Public Outreach, (2) Encourage Regionalization, (3) Educate the Public on SW VA Wastewater Needs, (4) Recruit Wastewater Operators (5) Focus on Decentralized Systems, (6) Identify Funding Sources. Many of the communities in Southwest Virginia are disadvantaged and the SWWAG has played and will continue to play an active role in these communities.

Update the on-site septic program guidelines.

In late FY2023, DEQ applied for and was awarded assistance from EPA for a Nonpoint Source Pilot Project – Expanding Virginia CWSRF Financing for Decentralized Wastewater Treatment Systems and Living Shorelines. Throughout FY2024, CWFAP staff worked closely with EPA TA staff and their consultant to evaluate the current VCWRLF offerings and develop opportunities to expand access to funding for on-site septic projects. Once the final report is provided, DEQ will evaluate the alternatives and update the on-site septic program guidelines.

IV. DETAILS OF ACCOMPLISHMENTS

A. Fund Financial Status

1. Binding Commitments

As detailed in Exhibit 2, DEQ entered binding commitments totaling \$37,681,338.45 during this twelve-month reporting period.

As a condition of the Operating Agreement, DEQ agreed that binding commitments totaling at least 120% of Federal payments to DEQ would be made within one year. As of June 30, 2024, binding commitments totaled \$1,129,947,436.58 or 356.08% of Federal payments received as of June 30, 2024, thereby exceeding this requirement.

2. Sources of Funds

Exhibit 3 shows the sources of the Fund's money for FY 2024, of which \$15,352,000 was made available from the FY 2023 Capitalization Grant, \$42,658,000 from the FY 2023 BIL Supplemental Grant, and \$4,352,000 from the FY 2023 Emerging Contaminants in the Letter of Credit account established for the Fund. As of June 30, 2024, money in the Fund had earned cumulative interest in the amount of \$147,331,650 in addition to the cumulative principal and interest payments from loan recipients of \$1,535,519,988. See Figure 7 below for more details. Note: Amount reported to DEQ excludes the Change in Fair Value for the Non-Pledged Loan Accounts [\$6,605,351 and AgBMP Loans [\$228,681] as well as the Gain on the Sale of Investments - Non-Pledged Accounts [\$-3,482,781], and AgBMP accounts [\$-131,002].



3. Administrative Fees

In FY 2004, the Board approved the implementation of an administrative fee to be placed on all VCWRLF ceiling rate loans. VRA began collecting this administrative fee as a component of loan interest on such loans in FY 2005. In FY 2020, the Board approved extending the application of the administrative fee to all interest-bearing loans. VRA has established a Wastewater Administrative Fee cash account to collect loan administration and bond structuring fees.

4. Disbursements and Guarantees

Exhibit 4 provides a breakdown of FY 2024 disbursements by quarter. Disbursements made from federal and state funds totaled \$59,211,329.58. In addition, disbursements totaling \$82,148,776.37 were made from loan repayments. **The combined total of all disbursements in FY 2024 was \$141,360,105.95.** Figure 8 demonstrates an upward trend in disbursements FY 2020 through FY 2022, with progressive dips beginning in FY 2022.



5. Financial Statements

Exhibits 5, 6, and 7 represent the financial statements for the Virginia Water Facilities Revolving Fund. These exhibits include schedule of assets, liabilities and fund equity; schedule of revenues, expenses and changes in fund equity; and statement of cash flows.

Credit Risk of the SRF

DEQ's program has been designed to minimize the default risk associated with making loans to the program participants. Detailed financial analyses and credit summaries are performed by the VRA for each applicant prior to entering a loan commitment. Each loan recipient must also establish one or more dedicated sources of revenue for repayment of the loan. Dedicated sources of revenue can be water and/or sewer revenue pledges, general tax pledges or a combined pledge of revenues and full faith and credit. Credit assessment of a subset of Ag BMP loans is conducted by the Farm Credit Association. It is understood that these loans carry an inherently higher level of risk than the municipal loans.

Exhibit 9 shows no VCWRLF Loan Payments outstanding on June 30, 2024. The Ag BMP Loan Payments outstanding on June 30, 2024, shown in Exhibit 9, are related to six (6) farmers.

Exhibit 10 shows the type of financial assistance that has been provided along with the credit rating of the loan recipient. The table shows that approximately 78% of all loans closed have gone to communities that have a bond rating of A or above.

B. Provisions of the Operating Agreement/Conditions of the Grant

DEQ agreed to several conditions in the Operating Agreement and Capitalization, BIL Supplemental, and Emerging Contaminant Grant Agreements. Conditions as described in the Operating Agreement have been met.

1. Provide a State Match

Virginia has deposited payments that total at least 20% of the capitalization grant payment, 10% of the BIL supplemental grant for FY 2022 and FY 2023, and 20% of the BIL supplemental grant for FY 2024 into the Fund as demonstrated in Exhibit 3.

2. Binding Commitments Within One Year

DEQ entered binding commitments to provide assistance from the Fund in amounts equal to or greater than 120% of each grant payment within one year after receipt of each grant payment as demonstrated in Exhibit 2.

3. Expeditious and Timely Expenditure

DEQ disbursed all cash draws and other available Fund money in a timely and expeditious manner.

4. Eligible Activities

DEQ monitors each project to ensure EPA's eligibility requirements are followed. All activities financed were eligible under Section 212 and Section 319 of the Clean Water Act.

5. MBE/WBE Objective

DEQ ensures that loan recipients follow the steps outlined in 40 CFR Part 33 regarding utilization of minority and/or women-owned businesses (MBE/WBE) in the construction of its projects.

DEQ requires up-front documentation from all contractors that must provide evidence of "good-faith effort" in the solicitation and utilization of MBE/WBE firms. The actual monitoring and reporting of the MBE/WBE utilization occurs during the project construction period, which, in most cases, is three years. DEQ receives utilization information from each loan recipient within 30 days after the end of each quarter in which sub-agreements were awarded. These forms provide documentation on actual MBE/WBE utilization during the course of the project.

6. Administration of the Revolving Loan Fund

The Water Quality Act of 1987 allows a state to set aside up to 4% of its SRF grant awards for administrative purposes. The Water Resources Reform and Development Act of 2014 (WRRDA) amended Section 603(d)(7) of the Federal Water Pollution Control Act to allow for two additional methods of calculating the maximum annual amount of CWSRF funds that may be used to cover the reasonable costs of administering the fund. The three options now include:

- 4% of all grant awards received by a State CWSRF;
- \$400,000: or
- 1/5% of the current valuation of the fund.

Virginia utilized the 4% calculation until the close of the FY 2019 capitalization grant and the opening of the FY 2020 grant in January 2021. Beginning with the FY 2020 grant, the program began utilizing the 1/5% calculation to determine the maximum annual amount of program administration funds. DEQ continually reviews program operating expenses and only authorizes the drawdown of funds for activities that are reasonable and necessary for program administration and project management activities.

Expenditures for FY 2024 program administration charged to the Capitalization Grant are identified in Exhibit 8.

V. EPA PROGRAM EVALUATION REPORT FINDINGS

The Program Evaluation Report (PER) is EPA's evaluation of Virginia's Clean Water Revolving Loan Fund Program and identifies strengths and areas for improvement within the program. EPA conducted an in-person review of DEQ's program between January 22-26, 2024. The draft PER was provided to DEQ on September 11, 2024, and DEQ provided comments on the document to EPA on September 24, 2024. The final PER was provided to DEQ on September 30, 2024. Overall, the PER was very positive about DEQ's program and includes one minor action item for Virginia to submit the Federal Financial Accountability and Transparency Act (FFATA) reporting for the FY 2021 capitalization grant.

VI. PROGRAM CHANGES AND STRATEGIC INITIATIVES

One legislative change to the program was passed in 2023. The Onsite Septic program added businesses as eligible applicants to fund the correction of failing onsite sewage disposal systems from a local program. The program guidelines for the Onsite Septic program will be revised to incorporate this change and submitted to the State Water Control Board (SWCB) for approval in the coming year.

During the reporting period, CWFAP staff continued implementation of the Southwest Virginia Pilot Program initiated in FY 2020. The pilot program utilizes additional subsidization as an incentive for localities in Southwest Virginia to perform sewer system evaluation surveys (SSES) – Phase 1 Step 1 projects – and target high priority repairs – Phase 1 Step 2 projects – that would significantly reduce sanitary sewer overflows and eliminate straight pipe discharges – Phase 2.

Applications to participate in Phase 1 Step 1 of the pilot program were solicited from June 1, 2020, to July 3, 2020. A total of 13 applications were received, for \$1,117,875 in assistance. All 13 projects were added to the FY 2021 PPL and SSES work has completed on all of those projects. FY 2022 applications to participate in Phase 1 Step 2 of the pilot program were solicited from Step 1 participants June 7, 2021, to July 30, 2021, seven applications targeting high priority repairs were

received totaling \$12,909,717. Phase 1 Step 1 applications were also solicited in FY 2022, the program received 16 applications totaling \$1,141,125 in assistance. FY 2023 applications to participate in Phase 1 Step 2 of the pilot program were solicited from Step 1 participants June 6, 2022, to July 29, 2022, 15 applications targeting high priority repairs were received totaling \$43,541,011. FY 2024 applications to participate in Phase 1 Step 2 of the pilot program were solicited from Step 1 participants June 5, 2023, to July 28, 2023, 4 applications targeting high priority repairs were received totaling \$7,250,130. FY 2024 applications to participate in Phase 1 Step 2 of the pilot program were solicited from Step 1 participants June 5, 2024, to July 28, 2024, 4 applications targeting high priority repairs were received totaling \$7,250,130. Additional information about the program can be found in Exhibit 14.

Other than changes to incorporate BIL requirements discussed in Section III, there were no significant changes to the VCWRLF program in FY 2024.

VII. SEWER OVERFLOW AND STORMWATER REUSE MUNICIPAL GRANT (OSG) PROGRAM

A cumulative total of \$5,059,250 in total funds (including \$840,250 in required match for FY 2020 through FY 2023), have been made available under the OSG Program since its inception in FY 2020 through FY 2024 (see Figure 9). Note that while FY 2024 data is included, EPA was notified that DEQ will be applying for the FY 2024 and FY 2025 OSG grants simultaneously during the FY 2025 fiscal year.



Funds allotted to the program in FY 2022 and FY 2023 totaling \$1,945,000 have been authorized to a suite of projects within the VCWRLF's Southwest Virginia Pilot Program. Figure 10 summarizes the project information for those authorized with FY 2022 and FY 2023 OSG grant funds. The match requirement for all the projects is being met through VCWRLF loans.

Virginia Clean Water Financing and Assistance Program Southwest Virginia Pilot Program

Overview

DEQ's Clean Water Financing and Assistance Program (CWFAP) is offering loan forgiveness to localities in Southwest Virginia to address critical wastewater infrastructure challenges through a new pilot program. Localities within DEQ's Southwest Regional Office boundary are encouraged to apply. These are the counties of Bland, Buchanan, Carroll, Dickenson, Grayson, Lee, Russell, Scott, Smyth, Tazewell, Washington, Wise, Wythe and the cities of Bristol, Calax and Norton.

This pilot program will use financial incentives to fund these types of critical projects: sewer system evaluation surveys, inflow and infiltration (I/I) studies, collection system repair projects to reduce I/I and/or sanitary sewer overflows (SSO), and projects that eliminate straight pipe, gray water, and discharges of partially treated wastewater to surface waters in the region. In addition to improving and protecting water quality, the program will foster asset management and promote fiscal sustainability.

This pilot program is especially important to Southwest Virginia, in which many localities have difficulty funding certain types of projects that do not increase revenue streams. In addition to demographic challenges, the region is home to several ecologically important watersheds like the Clinch, Powell and Holston River Watersheds. These river systems support the highest number of rare and imperiled fish and freshwater mussel species in North America, and provide a critical water supply for several communities in Southwest Virginia.

Phase 1

Goal: Reduce inflow and infiltration and eliminate sanitary sewer overflows

Sewer system evaluation surveys and collection system repairs are necessary to reduce I/I that cause sanitary sewer overflows. In addition to SSOs, I/I can adversely affect hydraulic capacity in wastewater treatment plants and cause permit violations. Collection system rehabilitation projects contribute to lower operational costs and reduced environmental and public health impacts in the communities where these projects are undertaken. Through Phase 1 of the pilot program DEQ will:

- Fund sanitary sewer evaluation study (SSES) and collection system repairs to reduce I/I, eliminate SSOs and reduce hydraulic overload in wastewater treatment plants.
- Encourage applications using incentives of principal forgiveness and favorable loan terms.

Steps to Participate Phase 1 Step 1

- 1. Political subdivision (county/city/service authority) submits application to fund SSES if initial screening criteria show one or more of the following:
 - Under current enforcement action for violation of 95% flow policy as stated in the VPDES permit for the facility
 - b. Hows exceeding 125 gpcd during periods of high groundwater
 - c. Flows exceeding 275 gpcd during precipitation events
 - d. Multiple reported rainfall-induced SSOs in six months prior to application submittal
- 2. DEQ-CWFAP reviews application and determines if minimum criteria are met

- DEQ-CWFAP closes loan or funding agreement (assuming financial capability is met) and provides up to 75% principle forgiveness for SSES (study and report). Recipient provides 25% match (using cash, other agency grant, or VCWRLF loan) and has 18 months from loan closing to complete SSES.
- 4. Applicant submits SSES report (with Asset Management Plan, cost-effective analysis, and list of priority repairs) to DEQ for review.
- 5. DEQ and the applicant meet to discuss the SSES report, outcomes and recommendations and determine list of highest priority repairs.

Steps to Participate Phase 1 Step 2

- 6. Political subdivision (county/city/political subdivision) submits application for highest priority repairs as determined by DEQ (1st solicitation or cycle after SSES review meeting).
- 7. DEQ-CWFAP closes loan (assuming financial capability is met) and provides up to 50% principal forgiveness to address highest priority repairs as determined by DEQ and based upon availability of principal forgiveness funds.
- 8. Applicant completes repair work within 15 months of loan closing.
- 9. Applicant has or develops sewer use ordinance that prohibits connections to the sanitary sewer system from stormwater sources such as downspouts, basement drains, yard drains, conveyance systems (drop inlets, catch basins, etc.) and DEQ approves before final disbursement.

Expected Outcomes

- Recipients are expected to report all sanitary sewer overflows (SSOs). This demonstrates the existence of SSOs.
 Communities with reported rainfall-induced SSOs will get priority funding over those who do not report.
- Applicants conduct SSES that culminates in a report to include:

Report and Analysis

- a. I/I amounts
- b. Hydraulic analysis (if warranted)
- c. Cost-effective analysis
- d. Rehabilitation plan by priority phases (an outline is sufficient)
- e. Up-to-date maps (GIS if available) that show collection system and deficiency locations
- f. Basic Asset Management Plan (AMP) AMP requirements listed below
- g. Priority list of repairs (SSES priority list can be used as basis for next CWSRF loan application). This can be in the form of a Capital Improvements Plan and utilize information from AMP.

Asset Management Plan

- a. Inventory of collection system
- b. Age of inventoried units
- c. Useful life, and remaining useful life
- d. Current value (depreciated value of the asset)
- e. Present cost (value of the asset today if it is replaced)
- f. Replacement cost (expected cost when the life of the asset expires)
- g. Projected revenues, expenses, and change in net position
